ASSEMBLY INSTRUCTIONS

Refer to parts drawing on page 5 for component descriptions

- 1) Slide wheel support bar (#8) through vertical bar (L) (#2) and secure with, (M8 x 50) bolt, washer and lock nut.
Repeat for right side, using vertical bar (R) (#3).



- 2) Fasten casters (#13) into the wheel support bar (#8), placing the casters with locks on the long end of the wheel support bar.
Repeat for both sides



3) Slide the lower cross tube (#7) into the assembled sections as shown below. Secure with (M8 x 50) bolts, washers and lock nuts.




4) Attach the center cross tube (#16) and vertical bar extensions (#15) as shown below and secure with (M8 x 50) bolts, washers and lock nuts.

5) Attach the upper cross tube (#1) to the top of the assembly and secure with (M8 x 50) bolts, washers and lock nuts.



6) Attached the mesh shelves (#6) to the lower side of the support arm with holes (#5) and secure with bolts (M8x40), and lock nuts.



7) Slide the 3 assembled mesh shelf assemblies over upright pins at your desired height.



8) The support arms without holes (#4) are hung near the top of the assembled frame




9) Hang hooks (#14) from shelves or cross tubes
